ANNUAL REPORT OF PASTOR STEVE SOLBERG - 2021

Dear brothers and sisters, grace to you and peace from God our Father and the Lord Jesus Christ by the gifting of the Holy Spirit. Amen.

2022 is the 60th year of my birth. Depending on your perspective you may think me old, young, or somewhere in the middle. As a young pastor in my late-twenties, I once knelt beside the wheelchair of a 90-some-year-old woman. "Pastor," she prophesied, "life is like a roll of toilet paper; the longer you use it, the faster it goes." That dear sister-in-Christ knew that of which she spoke! 33 years of my ordained ministry have rolled by, 13 of them lived in your midst. What a blessing and privilege to be your pastor! 9 of those 13 years, of course, had been with Pastor Marcia at my side and me at hers. She, too, counted being your pastor a blessing and privilege. God gifted us, pastors and congregation, with each other. Through much we have together journeyed, and now – in the blink of an eye! - we find ourselves in 2022.

I ask for your indulgence as my 2021 report reflects not just on last year, but all our years together. Here you'll find no order of priority or timing. Here you'll find my remembering, cherishing, and giving thanks to God for...

- Our weekly physical gatherings as a faith community in Word & Sacrament, faith formation, fellowship, and service. How good it is to gather! May the experience of our pandemic isolations increase our use of these ordinary-turned-extraordinary disciplines and routines of community.
- The people with whom I'm privileged to work our gifted, caring staff, our council and committee leaders so devoted to God and devoted to you as Immanuel, and each of you, O Immanuel, with your stories of questions, faith, hope, and love.
- Our worship life lived with high quality, creative, and colorful leadership from our musicians, seasonal decorators, and worship leaders. I pray you have intimately known worship as a verb in your weekly rhythm, not simply as a noun at some distance.
- Genuine care of one another in the body of Christ, including the formation and ongoing ministry of our Lay Eucharistic Ministry through which our homebound are remembered and included, extending the communion rail into many a home and institution. Worship services celebrated in area nursing and assisted living homes. Your care for Pastor Marcia and me, as well as our daughters, amidst 8 years of ovarian cancer, allowed me firsthand experience of your love.
- Prayer ministry that included public and private prayers, our prayer chain, and celebration of God's answers. The tool of Transformation Prayer Ministry (TPM) has given Christ Jesus' miraculous exchange of painful inner lies and beliefs for God's own liberating truth and peace.
- Humble Christian claim of each other in the body of Christ, not excluding another from fellowship because of wide-ranging perspectives, but holding one another in the love of Christ Jesus our Lord. Christ has given us boldness to listen, confess, absolve, exhort, share Christ, and live.
- Continuously forming faith through Bible overviews, from Bethel Bible Series to Crossways, and other in-depth studies of Bible books and life topics. In 2021 we even focused on the gift of Holy Communion and its challenges of use during pandemic.
- Life-changing mission trips to storm-impacted New Orleans, sharing life stories, carpentry skills, hope, and more with gumbo-loving people as well as local Habitat for Humanity builds.
- Planning, funding, and staffing local food packaging efforts that touched people worldwide through *Feed My Starving Children* and other non-profit food organizations.
- Youth trips that carried our young people to life-transformative experiences regionally in places like Minneapolis and nationally in places like Houston, Detroit, and soon again Minneapolis.
- Fellowship opportunities with families of various ages and make-up. Together we enjoyed Canoeing the Autrain River, the Hayes Corn Maze, Advent wreath-making, football games on big screens, progressive dinners, and the like.

- Caring for neighbors in need through financial support during food, housing, medical, transportation, and other challenges using our member-supported Good Samaritan Fund. Using hands and other skills in people homes to help them rebuild lives. Immanuel is known in community for our caring presence.
- Supplying warm winter clothing to local children in need and food to local food pantry shelves through our ecumenical efforts of *Project Keep Kids Warm* and *Project Feed a Neighbor*, inviting generous donations by bathing our community in collection bags and picking up the same later filled with hope. In 2021 approximately 250 local children were clothed with warm winter gear.
- Difference-making experiments like *Love INC Central UP* that better coordinated local congregation's response to and advocacy with neighbors in crisis... and *WIN for Christ* that ecumenically cared for and empowered youth across the school district lines of Westwood, Ishpeming, and Negaunee.
- Ecumenical Vacation Bible School led by Immanuel people, coordinating and sharing the incredible gifts of our Christian community with the young families and youth of Negaunee and beyond.
- Fortune Lake Lutheran Camp ministry supported with generous scholarships and well-used by youth and families during summer weeks, fall and winter retreats, and Bible Day Camp here at Immanuel during Vacation Bible School.
- Weekly youth ministries of Sunday School, confirmation gatherings, small groups, service projects, sleepovers, etc., that more deeply connected our youth with God, each other, this congregation, neighbor, and life.
- Faith mentoring begun between adult mentors and 8th grade mentees, meeting monthly for deepening connections as well as good pizza and more.
- Online access to our worship life, faith formation offerings, congregational meetings, and more through our new website, Facebook page and groups, tablet ministry, and Zoom meetings. Our sense and definition of community has broadened, indeed.
- The face of Immanuel ever-changing as the new-in-faith are baptized, new people become members, and former members go with God to other communities or now sleep in the Lord. Our congregation is a place where people are safe to linger and explore, participating in worship, Bible studies, and other ministries, while not necessarily committing to all of them.
- Grieving people have found consoling ministry through visits, funerals, and receptions, as well as sharing of time-appropriate grief resources and other follow-up.
- Those in love have received support not only to plan their wedding but also to grow their relationship through premarital conversations, exercises, counseling, and God's enough for each new day.
- Maintenance and renovation of our building including office and classroom spaces, a new core heating system, carpeting in the fellowship hall, upper and lower levels, and a new metal roof that will hopefully outlast this generation.
- Monthly Mission Emphases begun and used to great effect toward discovery, prayer support, and financial generosity that has often led the synod in designated financial giving over and above our annually budgeted proportional giving to our Northern Great Lakes Synod and Evangelical Lutheran Church in America. Room at the Inn and other ministries have benefited financially and with volunteers.
- Stewardship emphases and campaigns that celebrate and encourage generous proportional, first-fruit financial giving as well as sharing of our various spiritual gifts. So many touches behind the scenes from office to kitchen to maintenance to council/committee leadership and more prove your generous use of your time and talents.
- The endowment investments of past stewards have been faithfully and unselfishly used to God's glory, inspiring all to consider our own end-of-life stewardship through final wills and testaments.
- Tanzanian connections with our companion congregation Yombo Lutheran Parish in Dar es Salaam, people exchanging visits, prayers, ideas, and love. Together we have both celebrated and grieved, including the death of Teddy Mwakilembe. We have even twice been blessed with visits from Bishop Alex Malasusa of the Eastern & Coastal Diocese of the Evangelical Lutheran Church in Tanzania.

- Patiently navigating this COVID pandemic, we have discovered anew that suffering does indeed
 produce endurance, and endurance produces character, and character produces hope, and hope does not
 disappoint.
- All the ministries that I have not committed here to writing that you wish I had included. There is so much! Wow!

So how much paper is still left on the roll? No worries there! God provides for us as a congregation and for us as individual Christians. We are Immanuel, renewing lives in Christ Jesus through the Holy Spirit, and God who has provided these past 13 years, Immanuel's past 134+ years, and more will faithfully provide everything needed in 2022 and beyond.

I'm going to conclude with yet another metaphor. If you're feeling bold, feel free to mix metaphors, but I will not. I invite you to see 2022 as a pilgrimage. According to Wikipedia, "A pilgrimage is a journey, often into an unknown or foreign place, where a person goes in search of new or expanded meaning about their self, others, nature, or a higher good, through the experience. It can lead to a personal transformation, after which the pilgrim returns to their daily life." In 2022 and beyond, let us walk a pilgrimage, one step at a time, on an unknown path, going with God. Following the way of Jesus on such a pilgrimage may or may not return us to our remembered daily lives of old, but that's OK. Faith is not a destination.

ANNUAL REPORT OF PARISH ADMINISTRATOR - 2021

In 2021, I enjoyed navigating and learning the duties of bookkeeper, and would like to thank Dan Kill for the many hours of training he provided.

After a long search in a strange hiring climate, I'm happy and thankful Immanuel has hired a new part time custodian, Tyler Taseris, to keep the church clean, shiny and safe.

The sanctuary painting project went smoothly and I hope you agree the results are beautiful. We worked with a terrific painting contractor who, along with some members of our congregation, donated generously to the painting fundraiser. Thank you!

In addition to focusing my efforts on budget preparation, I assisted with forming a contingency fund task group. The purpose of the contingency fund is to provide funding for capital projects related to the church building that are not covered in the operating budget.

As approved by council, we will begin depositing to the Contingency Fund as follows:

- Target 2% of annual giving
- \$1,200 from 2021 budget
- \$6,000 from the General Fund

On trend with last year, the 2022 budget includes pay increases for all staff.

My day-to-day responsibilities as Parish Administrator continue to cover meeting coordination, tech team scheduling, miscellaneous administrative duties, including purchasing, and working closely with the property and staff support committees.

ANNUAL REPORT OF BISHOP KATHRYN FINEGAN FOR THE REPORT YER 2021

NORTHERN GREAT LAKES SYNOD



Now faith is the assurance of things hoped for, the conviction of things not seen.

~Hebrews 11:1

Dear Northern Great Lakes Synod,

As this Year of Hope 2021 comes to a close, we shift our focus to Faith for the year 2022. Faith is, of course, connected to Hope as our Faith in the Spirit of the Living Christ is the source of our faith and our hope.

While each generation has been marked by its own challenges, it's hard not to feel like our time in history is somehow exceptional, perhaps because we are the ones who are living it. The past couple of years have certainly been distinctive. We are living in a time of contrasts and simultaneous opposites:

- Weariness and opportunity
- Grief and creativity
- Loss of traditions and forging something new
- Polarization and common mission
- Apart but together

Living in the tension of seemingly opposing forces is exhausting. And yet, perhaps it is only in that in-between space that we are able to move forward, like walking a ridge line, carefully balancing between two valleys that drop steeply to either side. Every step must be calculated and considered to avoid careening down a slippery slope.

I do believe we entered this pandemic thinking that somehow it would end and we would all go back to the way things were. Now, I am thinking that it is not about looking for an end, but rather shifting into a new way of being. Included in the charges given to a pastor at an ordination is this exhortation:

"So discipline yourselves in life and teaching that you preserve the truth, giving no occasion for false security or illusory hope."

I do not wish to give illusory hope, encouraging you to hold on for some near or distant day when the pandemic will be over and things will get back to "normal". The shifting and adapting we are doing now may well be permanent and not just a temporary adjustment for extraordinary circumstances.

As we travel the ridgeline of 2022, I encourage you to join me and the whole synod in a focus on Faith. The whole point of being church, the whole reason God created the church in the first place, was to share the good news of Jesus. When so much of the future remains uncertain, we have this core mission to guide our steps.

For 2022, I believe we will find blessing as we dig into what we believe, why we believe it, and what difference that belief makes to who we are as people trying to follow Jesus, and what it means for how we live in the world. Whether you join a Synod-wide Lifelong Faith Formation class or participate in a small group Bible Study in your congregation or with a group of friends, I ask you engage in a new effort, a new discipline, to deepen your faith, and I promise to do the same. Together, we will

do the same. Together, we will walk this narrow path through the tension that 2022 brings and find our way into becoming the future church that God is bringing into being.

Faith Formation Team The working Role/Scope of this Committee as defined by Immanuel's Constitution: To promote faith in Christ Jesus that is lifelong, by:

- Exercising oversight of education ministries within the congregation
- Planning faith formation activities for the whole congregation
- Collaborating with other Immanuel Committees to meet these objectives.

The Faith Formation committee met 7 times- twice on Zoom, then resuming face-to-face meetings in May.

Sunday School

- The winter/spring semester, classes were available through Immanuel's webpage.

Adult Education Opportunities

- Wednesday Morning Bible Studies focusing on the scriptures for the upcoming Sunday began the year strictly via Zoom. In the spring the studies added an in person component.
- Thursday evening Zoom/and or in person. Pastor Steve led studies on Colossians and Holy Communion.
- Via their **Gather** Magazine, Women of the Evangelical Lutheran Church provides monthly Bible Study on a common topic throughout the ELCA.
- Online "Life- Long Faith Formation" offerings through Northern Great Lakes Synod were available during Winter and Fall courses.
- New Member Orientations were conducted by Pastor Steve.

Collaboration with other Immanuel Groups was less frequent- again because COVID precluded big events.

- September God's Work, Our Hands Collaboration with Social Ministry Committee

We waited until the Covid-19 vaccination was available for ages 5-12 before hosting overnight events for this age group. As of today 70 estimates of financial giving were returned from the people of this church for the General Fund for 2022. This compares favorably with 2021 when 45 were received. The dollar amounts to the general fund for 2022 are as of this date \$211,988, comparing to \$157,000 for 2021. Congratulations to this congregation for "stepping up." About \$52,000 is estimated for the 2022 Building Fund compared to last year's \$42,000. This is an exceptional increase in giving! In addition "Time and Talent" forms have been returned by many of our congregational members so that the church leadership can be aware of the interest by our people in service to God and this congregation. Thank you for this warm embrace of our work together. What a generous group of people God has assembled at Immanuel in Negaunee!

Today our congregation gathers in prayer and hope to begin another year of ministry. We bring with us the memory of a year like no other, even as we move into a future that we cannot yet imagine. Yet even now, as in every age, God is our refuge and strength. In times of plenty and want, in times of conflict and peace, in times of growing and pruning, we remember:

God has called us for such a time as this.

We remember the past year with lament and gratitude. We have lost so much, and so much still feels uncertain. We have also witnessed God's hand at work in new and unexpected ways. We delight at hidden seeds bearing surprising and wonderful fruit. When our own resources fail, when we cannot predict the future, when we must rely on God alone, we remember:

God has called us for such a time as this.

We celebrate this moment and the many ways God has held us together as a community. We give thanks for the gift of our church building and the welcome it provides, even as we bless God for the marvel of technology and the new bonds of connection it makes possible. When our bodies need sanctuary, when our minds need expanding, when your grace must transcend our limitations, we remember:

God has called us for such a time as this.

We look ahead to the road we will travel together this year. We anticipate and receive with joy the new gifts God's love has planned. We pray for the grace to let go of what has served its holy purpose. When we are trailblazers or followers, when we are seekers or visionaries, when we must walk by faith and not by sight, we remember:

God has called us for such a time as this.

And so we pray: Grace our meeting, O God, with the gift of your Holy Spirit: the Spirit who has guided the church from the beginning, the Spirit of our risen Lord Jesus, the Spirit who sends us as healers and restorers of your beloved world. You are the source of our life together. You are the rock and cornerstone.

You have called us for such a time as this.

Change and the need for creativity have become constants over the last year and a half in many aspects of life, including the church. This was the case for **Living Christ <u>Lutheran Church</u>** in Flagstaff, Ariz., even before a global pandemic caused many of us to rethink what it means to be church. Generosity from all three expressions of the ELCA (the churchwide organization, the Grand Canyon Synod and members of Living Christ) helped turn a congregation "on the road out of town, near the mall" into an online presence reaching over 500 people a week from Phoenix to the Philippines, (Read more about Living Christ in the current issue of "Stories of Faith in **Action**" at **ELCA.org/SOFIA**.)

Many other congregations have found new ways to connect both when inperson worship was impossible and when congregations began to return to their sanctuaries. Generosity, especially through Mission Support, helped us find and support these new ways of being connected. Early in the pandemic, ELCA Worship launched the "Worship in the Home" webpage, with Scripture, hymn links, prayers and reflections for each

Sunday. These resources were and continue to be used in congregations across the ELCA—even at **Sitka Lutheran Church** in Alaska, whose members printed and hand-delivered "Worship in the Home" resources to fellow members without internet access.

Change and creativity have taught us many things. As Pastor Sandra Rudd of Sitka Lutheran Church noted, "The pandemic was a stark illustration of the fact that the church is not a building. A lot of people say that, but we didn't fully know it until we didn't have a building to use. We learned that there are many ways to be connected as the church." Throughout the pandemic, the ELCA has changed and adapted, doing ministry in new and creative ways, because of the generosity of its members. Even now, you may be gathering in a new way for your annual meeting, to discern how you will steward the gifts shared generously with your congregation to do ministry in your community and beyond. As you have these important conversations, remember that your gifts of time, talent and resources have helped create new spaces beyond our walls and buildings where we continue to worship, serve and love God and each other.
